## **CONSENT AGENDA**

## **INFORMATION ITEMS**

President Klyczek stated the IPEDS Report is an annual report that is received which compares and includes NCCC in a group of 12 other New York State community colleges. Also our Child Development Center has been awarded the National Association for the Education of Young Children accreditation for five years with almost a 100% passing rate. Congratulations to Vonetta Rhodes, Director of the Child Development Center and Vice President Julia Pitman who oversees that area. There being no other questions, the following items were received and filed: Personnel Status Chart, Facilities Update, Foundation Report, Prospective Request for Proposals, IPEDS Report and the NAEYC Accreditation.

## **COMMITTEE REPORTS**

### **Finance**

Craig Stevens and Jon Miller from The Bonadio Group presented the audit to the finance committee a few weeks ago; today they presented to the full board; they also provided a handout of the Financial Statements. Trustee Virtuoso thanked The Bonadio Group for their presentation. It was moved by Trustee Virtuoso and seconded by Trustee Ginestre to accept the financial statements / audit as of August 31, 2014 and 2013.

Trustee Virtuoso provided a handout of the SUNY Community College Annual Report Summary 2013-14. President Klyczek stated it is an annual overview of 30 community colleges, showing categories of information showing how we looked compared to the other 29 SUNY community colleges. It shows comparisons in Campus Operating Revenues and Expenses, Campus Operating Revenues and Expenses per FTE, Campus Statistical Data and Analysis. Chairman Ward thanked Trustee Virtuoso, President Klyczek and Vice President Schickling on the work they did on the audit report with The Bonadio Group.

President Klyczek reported that:

- Several foundation handouts were provided announcing the Alumni 5K Run/Walk on May 1, 2015 application or sponsorship, along with a form to recommend a Distinguished

- **After this meeting, we have arranged a tour of the SimMom Lab with Linda Kilger. Sales people will be demonstrating a computer controlled pregnant manikin for our nursing division.**
- **Stamats marketing: We are in two final stages of the project for internal and external communication, marketing and branding work. Stamats was here last week working with a number of our enrollment management groups, and will be back with a full report to help us develop key points in branding exercises, etc.**

- **The Learning Commons RFP is out and published and is only for the architecture and engineering portion. A required information meeting is scheduled for March 26 at 2:00 p.m. for all those who responded to the RFP and to have their questions answered.**
- **We have received three dates from Narissa Polino for the board self-assessment retreat. Dates are Friday May 8, Monday May 11, and Tuesday May 12.
