- President Murabito stated we have organized the SEM (Strategic Enrollment Management) meetings via
  direction from SUNY. Each campus is working with SUNY to develop a new SEM Plan, and the good news is
  what we have in place is a good starting point. We look forward to meeting with SUNY reps in the near future
  for further direction.
- President Murabito continues to meet with WNY community college presidents, each meeting becomes more helpful as campus topics are shared and discussed.
- The new Erie Community College President was selected; Dr. David Balkin will begin his new role on February 1. Dr. Balkin previously served as Chancellor for Ivy Tech Community College's South Bend-Elkhart campus in Indiana.
- President Murabito met with the SUNY presidents from across the state and discussed the spring reopening plan; we are not recommending any changes to our spring schedule, plan on keeping spring break as scheduled in mid-March.
- President Murabito met with John Simon and his counterparts, along with Father Maher and Dr. Coley from Niagara University, pertaining to the World Weather Corp (Teletech) for possible downtown housing, world weather center, etc.
- On January 12, we hosted the 26<sup>th</sup> Annual Tech Wars competition. Area schools attended with upwards of 300 students on campus, and each year the students like to highlight their talents.
- Congratulations to Carolyn Stanko and Matthew Clarcq as the recipients of the Dr. Carol Jamison Award, which was held via ZOOM.
- The All College Meeting will be held virtually on Thursday, February 3 at 9:30 a.m. President Murabito encouraged trustees to join if possible.
- NCCC has been selected by the Governor, as one of the SUNY campuses to host a COVID-19 test site beginning today. We are using the vacated snack bar in G building, curtained off by pipe and drape. At this time, we are unsure of the duration of this test site.

# NCCC EDUCATIONAL SUPPORT PERSONNEL ASSOCIATION, NYSUT/NY

Background: Niagara County Community College in good faith have negotiated a six-year collective bargaining agreement ('Agreement") with the NCCC EDUCATIONAL SUPPORT PERSONNEL ASSOCIATION, NYSUT/NY concerning wages, terms, and other conditions of employment for the term of September 1, 2018, through August 31, 2024. At the meeting of the Board of Trustees of Niagara County Community College on January 18, 2022 the following resolution was proposed and approved by the board:

WHEREAS, Niagara County Community College and Niagara County Community College NCCC EDUCATIONAL SUPPORT PERSONNEL ASSOCIATION, NYSUT/NY reached a settlement agreement on December 16,2021 outlining the negotiated changes as attached.

**WHEREAS**, the Agreement has been lawful and properly ratified by the membership of the NCCC EDUCATIONAL SUPPORT PERSONNEL ASSOCIATION, NYSUT/NY on January 7, 2022.

**WHEREAS**, Niagara County Community College and NCCC EDUCATIONAL SUPPORT PERSONNEL ASSOCIATION, NYSUT/NY that the best interests for both parties are served by executing the aforesaid amendment.

**THEREFORE**, be it resolved that the Board of Trustees approve the ratification of the union contract between Niagara County Community College and the NCCC EDUCATIONAL SUPPORT PERSONNEL ASSOCIATION, NYSUT/NY effective January 18, 2022.
