## PAYMENT POLICY

SUNY Niagara requires all students to pay full account balance by the payment due date or enroll in our payment plan. If you enroll in classes after the payment due date, payment in full is due at the time of registration. If your account balance is not paid in full any time after the payment due date, or you are not enrolled in a payment plan, your course schedule **may** be dropped.

## PAY IN FULL OPTIONS:

1. Online: Pay by credit or debit card, via Banner Web. We accept Visa, Mastercard and Discover Cards.
2. In-person: Pay by credit card, debit card, cash, personal check, money order, or cashier's check at the Cashier's Office, Room A205.
3. Financial Aid.

## PAYMENT PLAN OPTION:

If you are unable to pay your student account balance in full by the payment due date or at time of registration, you may opt to spread the payments over time by enrolling in one of our payment plans - available to ALL students.

## PAYMENT PLAN INSTALLMENT SCHEDULES

All plans incur a \$40 non-refundable fee due with the first installment; payment calculations based on outstanding portion of tuition & fees. 4 choices are outlined below:

**Plan A:** 33% due 8/15/24, 33% due 9/15/24, balance 10/15/24.

**Plan B:** 25% due 7/15/24, 25% due 8/15/24, 25% due 9/15/24, balance due 10/15/2024.

**Plan C:** 20% due 7/15/24, 20% due 8/15/24, 20% due 9/15/24, 20% due 10/15/24, balance due 11/15/24.\*\*

**Plan D:** 15% due 8/15/24, 15% due 9/15/24, 35% due 10/15/24, balance due 11/15/24.\*\*

**\*\*NOTE:** Plans C & D final payments are due after Fall accounts are fully due, and are likely to experience a Cashier Hold until paid in full, which will prevent future registration.

## REFUNDS/WITHDRAWALS

Refunds of tuition and fees will be based on your official withdrawal date in accordance with College policy and State University of New York regulations.

### How to Withdraw From the College:

If you register for courses and decide not to attend, you **MUST** officially withdraw from SUNY Niagara. Non-attendance and/or non-payment will not constitute withdrawal from class(es) and refunds will not apply. To obtain a full refund, you **MUST** withdraw prior to the last day of 0% liability (see above refund schedule). Before you file a withdrawal form it is strongly encouraged you speak with a Success Coach in the Student Success Center (D102) to explore options and receive important guidance. ## KNOW YOUR FINANCIAL OBLIGATION

All tuition and fees incurred as a result of course registration or other student activity are due and payable to SUNY Niagara, and are the student's responsibility to pay. Financial aid that appears on an account is only an estimate until earned. Financial aid eligibility changes because of non-attendance, insufficient academic progress and ineligible courses. Accounts with unpaid balances after Plan A & B final payment plan due date will be considered delinquent and a hold will be placed on the account. Holds prevent a student from registering for future classes and receiving diplomas and certificates. SUNY Niagara may refer delinquent accounts to an outside collection agency for further collection efforts. Student is responsible for paying the collection agency fee, which may be based on a percentage at a maximum of 33.3333% of the delinquent account, together with all costs and expenses, including reasonable attorney's fees, SUNY Niagara incurs in such collection efforts. Student's failure to pay financial obligation may be reported to credit bureaus, which will negatively impact credit scores.

## FINANCIAL AID

To use financial aid for tuition and fee charges, you must apply for Federal financial aid (FAFSA application) at least 3 weeks prior to payment due date to ensure federal aid is applied to your account. New York State aid programs require additional processing time.

Students with financial aid, scholarships or grant awards must E-sign the Financial Agreement to acknowledge that they wish to apply such credits towards the account balance due. Failure to E-sign puts your financial aid at risk. The form is available through Banner Web, under Student & Financial Aid.

### All financial aid is tentative!

Financial aid will not pay for classes you do not attend. If you do not plan to attend a class, you must login to Banner Web and go to Add/Drop classes to remove course(s) from your schedule prior to the start of the term (see Refund Schedule). Failure to do so places the financial payment responsibility on you. If you no longer plan to attend any classes at SUNY Niagara, see the HOW TO WITHDRAW FROM THE COLLEGE section.

Students typically use the following financial aid resources to cover tuition, fees and other charges:

**Pell** - Federal grant ranging from \$370 to \$3,697 per semester for full-time study. Awards are prorated based on enrollment for part-time study.

**TAP** – NYS Tuition Assistance Program grant ranging from \$500 - \$2,832 (or tuition cost) per semester for full time study.

**APTS** –NYS Aid for part-time study grant up to \$2,000 per year.

**Excelsior Scholarship** – Maximum award up to \$2,750 per term. Visit [www.hesc.ny.gov](http://www.hesc.ny.gov) or contact Financial Aid for the latest information.

**William Ford Direct Loans** – Federal loans with eligibility determined on need and class status: Freshmen (earning 29 or less credit hours) may be eligible to borrow up to \$5,500; Sophomores (earning 30 or more credit hours) may be eligible to borrow up to \$6,500. Students considered “independent” have an additional \$4,000 eligibility under the unsubsidized portion of the loan.
